



Help Design the European Ocean Pact - Fisheries and Oceans Dialogues facilitated by the European Blue Forum

As announced in European Commission President von der Leyen's Political guidelines for the next European Commission 2024-2029, the European Commission is preparing a "European Ocean Pact" that should ensure coherence across all policy areas linked to the oceans. In her mission letter to the Commissioner for Fisheries and Oceans, Mr Costas Kadis, the President asks him to "organise Fisheries and Oceans Dialogues, notably to help design the European Ocean Pact in a collaborative and inclusive way and to listen to the views of all stakeholders, including small-scale and artisanal fisheries".

The European Blue Forum, launched in May 2023 has been working for more than a year around a diversity of topics, all converging to develop a sustainable and desirable future of the European seas. Based on its ability to mobilise its more than 600 members and engage with the 'Blue Community'; and wider European Citizens on matters related to the Blue Economy, the European Blue Forum has been invited to facilitate the first Fisheries and Oceans Dialogues on 5th March 2025 in Brussels to gather input to the upcoming European Ocean Pact.

Preliminary program

As we embark on the journey towards a sustainable and thriving future for our Ocean, it is imperative to recognize the interconnectedness of ocean health, biodiversity, and economic prosperity. The European Commission has outlined an ambitious vision for the next five years, encapsulated in the forthcoming European Ocean Pact. This pact aims to ensure coherence across all policy areas linked to the oceans, adopting a holistic approach to ocean governance.

The pact will strategically pursue the equally important objectives of **ensuring a healthy and productive ocean, by protecting biodiversity; boosting the EU's sustainable blue economy; expanding the EU's marine knowledge framework, reinforcing international ocean governance and developing resilience and opportunities for coastal communities**. As part of the event on 5th March 2025, we seek to gather diverse perspectives, particularly from small-scale and artisanal fisheries, to foster a comprehensive and inclusive framework for ocean governance.

The discussions in the main plenary room (GASP) and the side room (JENK) will be structured around four dynamic panel sessions. Each session will **incorporate resilience and opportunities for coastal communities as well as marine knowledge as transversal topics**.
